Description:	European beech pulpwood is long and short wood of the species <i>Fagus sylvatica</i> . It is debarked, chipped, and used for producing cellulose.

Specification

Tolerance and warping limits

In case of deviations from the quality and dimensions of European beach pulpwood as defined in the Lenzing specification, the following guidelines apply:

Decay and heart rot	Deducted as scrap (ballast). Over 20% content—shipment rejected.
Mildew	Beginning white rot fungus infestation, tolerance limit 5 % At 6 % or above, 25 % is deducted as scrap (ballast). Over 80 % content—shipment rejected.
Shaping deficiencies	Y-branches, windfall, and limb stubs cause poor debarking, technical problems, and wood loss. Tolerance limit 5 %; At 6% content—price discounted by 10 %
Thin wood	Cannot be processed for technical reasons. Deducted as scrap (ballast). Over 20 % content—shipment rejected.
Other wood types	This includes any type of wood other than European beech. Ash, maple, birch, and spruce are tolerated as admixtures. Their mass proportion is estimated when received. All other types of wood are sorted out, rejected, and not paid for. Over 20 % content—shipment rejected.
Misshapen wood	Wood of less than 1 m in length is deducted as ballast and not paid for. Wood above 6 m in length must be sorted out and cut down to length—deduction of 20 €/AMM.
